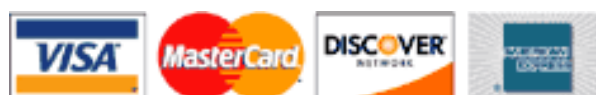

## **POLICY REGARDING REFUND OF TUITION AND OTHER FEES**

### **I. CANCELLATION BY STUDENT**

Any and all deposits or payments to Vintage RE Academy by a student for a particular course will be refunded in full, minus a \$25.00 administration fee, minus costs of book (n/a), if the student states in writing that he/she desires to cancel his/her attendance prior to the start of the second regularly scheduled class. After the start of the second class, all tuition and other costs are non-refundable. Any and all textbooks and materials purchased by the student are non-refundable. Any and all refunds to be paid by school to student by check within 60 days. For continuing education courses, the cancellation time period is replaced by the end of the first break.

### **II. TRANSFERS**
