**POLICY Y REGARDING REFUND OF TUITION AND OTHER FEES**

**I. CANCELLATION BY STUDENT**

Any and all deposits or payments to Vintage RE Academy by a student for a particular course will be refunded in full, minus a \$25.00 administration fee, minus costs of books, if applicable, if the student states in writing that he/she desires to cancel his/her attendance prior to the start of the second regularly scheduled class. After the start of the second class, all tuition and other costs are non-refundable. For continuing education classes, this time period is replaced by the beginning of the first break of the first class (10:30 AM on the first class day). Any and all refunds to be paid by school to student by check within 60 days.

**II. TRANSFERS**

If a student cannot attend a specific class or course that he/she originally was scheduled to attend, that person may transfer that deposit or money paid for the course to another date or course. There is no charge for this service. This may be done prior to the start of the second scheduled class.

**III. CANCELLATION OF CLASSES BY VINTAGE RE ACADEMY**

If Vintage RE Academy cancels a class due to inclement weather or some other situation, then that particular class will be rescheduled at some future date.

If Vintage RE Academy cancels an entire class, due to lack of enrollment or some other situation, then all deposits and other tuition paid will be refunded in full. In this case, students can transfer to another course at no additional cost.
